**NORTH CAROLINA STATE BOARD OF BARBER EXAMINERS  
MEETING MINUTES**

**June 16, 2014**

The meeting of the North Carolina State Board of Barber Examiners was called to order at 9:05 a.m., on June 16, 2014 at the Board's office at 5809-102 Departure Drive, Raleigh, North Carolina.

**1. 138A Ethics Awareness & Conflict of Interest**

This statement was read by Chairman Jackson. No board members indicated any potential or actual conflicts.

2. Approve/Disapprove Minutes

A motion was made by Chairman Jackson and seconded by Mr. Crumley to approve the minutes of the April 14, 2014. The motion passed unanimously and the minutes were signed by the members present at the April 14, 2014 meeting.

**New Business:**

3. Each Board member cast his/her vote for the annual election of Board officers. The members chose Mr. Warwick as the new Chairman and Mr. Hood as the new Vice Chairman. The casted votes are as follows:

4. Administrative Hearings (Show Cause)

The following individuals were served with a Notice of Hearing to appear before the Board for "Show Cause" for failure to pay past due civil penalties and attorney costs. None of the individuals appeared as required by the Notice of Hearing.

5. Administrative Hearings (Appeals)

- a) Nenad Simic: Mr. Simic appeared before the Board to request permission to open a barber school where the instructional and practical rooms are located in two (non adjacent) separate spaces in a mall. Both having a different address.

Mr. Simic made remarks to the Board. The Board questioned Mr. Simic.

- b) Emmitt Blount: Mr. Blount appeared before the Board to contest a citation for allowing an unlicensed barber to operate in his barber shop and to determine if his physical handicap (blindness) prevents him from being able to function as a licensed barber and barber shop manager.

Mr. Blount made remarks to the Board. The Board questioned Mr. Blount.

6. Applicants with felony convictions with petitions before the Board.

- a) William McIntosh Dr. Tony Reggi of the Department of Public Safety appeared before the Board on the behalf of Mr. McIntosh to request permission to obtain an unrestricted registered barber license.

Mr. was convicted in Chatham Superior Court on May 25, 2006 for Habitual Felon and three counts of Sell Schedule II. He completed the Harnett Barber Program in September 2009 and was issued a Provisional Barber license in 2011. He has worked at Southern Correctional Center, Randolph Correctional Institution, Dan River Prison Work Farm and New Hanover Correctional Institution. Mr. McIntosh has provided 10, 106 hours of service as a barber. On June 26, 2014, he will be released to Post Release Supervision in Chatham County.

Dr. Reggi made remarks to the Board. The Board questioned Dr. Reggi.

- b) Toma Tarrant: Dr. Tony Reggi of the Department of Public Safety appeared before the Board on the behalf of Mr. Tarrant to request permission to obtain an unrestricted registered barber license.

Mr. Tarrant was convicted in New Hanover Superior Court for two counts of Robbery with a Dangerous Weapon, Possession of a Firearm by a Felon and Possession of Stolen Goods. He completed the Harnett Barber Program in 2011 and was licensed with a Provisional Barber license in 2013. He has worked at the Tyrell Prison Work Farm and Scotland Correctional Institution. Mr. Tarrant has completed 1,596 hours of service as a barber. On August 8, 2014, he will be released to Post Release Supervision in Brunswick County.

Dr. Reggi made remarks to the Board. The Board questioned Dr. Reggi.

- c) Derrick Abgo: Mr. Agbo appeared before the Board to request permission to obtain an apprentice barber license.

Mr. Agbo was convicted in Guilford County Superior Court on January 30, 2009 for Attempted Break and Entry. He received a five to six month active sentence and three years supervised probation.

Mr. Agbo made remarks to the Board. The Board questioned Mr. Agbo.

- d) Kristopher Battle: Mr. Battle appeared before the Board to request permission to obtain an apprentice barber license.

Mr. Battle was convicted in Wayne Superior Court for Possession of Heroin and Maintaining a Place for the Selling of Controlled Substances on August 3, 2010. He received an active sentence of six to eight months and three years supervised probation. The judgment in these cases is not satisfied.

Mr. Battle made remarks to the Board. The Board questioned Mr. Battle.

- e) Tony Carmon: Mr. Carmon appeared before the Board to request permission to obtain an apprentice barber license.

Mr. Carmon was convicted in Pitt Superior Court for Robbery with a Dangerous Weapon and received an active sentence.

Mr. Carmon made remarks to the Board. The Board questioned Mr. Carmon.

- f) Caleb Hunt: Mr. Hunt appeared before the Board to request permission to obtain an apprentice barber license.

Mr. Hunt was charged with Embezzlement in Robeson County on February 16, 2013. The charge is pending and Mr. Hunt's attorney was contacted about Mr. Hunt discussing this case. Mr. Hunt chooses to explain his arrest and pending charges prior to disposition.

Mr. Hunt made remarks to the Board. The Board questioned Mr. Hunt.

- g) Joseph Mack: Mr. Mack appeared before the Board to request permission to obtain an apprentice barber license.

Mr. Mack was convicted in Mecklenburg Superior Court for Maintaining a Dwelling Place to Sell Controlled Substances on October 1, 2007. He received a two year probationary sentence and the judgment is not satisfied in this case.

Mr. Mack made remarks to the Board. The Board questioned Mr. Mack.

- h) Roosevelt McCullough: Mr. McCullough appeared before the Board to request permission to obtain an apprentice barber license.

Mr. McCullough was ordered to surrender his barber license for fifteen days until he paid civil penalties on April 30, 2008. He paid the penalties and costs and was reinstated. Mr. McCullough was convicted on July 7, 2008 for Felony Possession of Marijuana and Possession of a Firearm by a Felon in Mecklenburg Superior Court. He received an active sentence of fifteen to eighteen months and three years supervised probation.

Mr. McCullough made remarks to the Board. The Board questioned Mr. McCullough.

- i) Marquis McLean: Mr. McLean appeared before the Board to request permission to obtain an apprentice license.

Mr. McLean was convicted in Wake County Court for Felony Possession of Marijuana on October 9, 2012. He received an active sentence of four to fourteen months and eighteen months supervised probation which he is currently completing. The judgment in this case is not satisfied.

Mr. McLean made remarks to the Board. The Board questioned Mr. McLean.

- j) Noe Ramos: Mr. Ramos appeared before the Board to request permission to obtain an apprentice license.

Mr. Ramos was convicted for DWI and Driving while license was revoked in New Hanover County and placed on probation which will be completed on February 12, 2015.

Mr. Ramos made remarks to the Board. The Board questioned Mr. Ramos.

- k) Joshua Williams: Mr. Williams appeared before the Board to request permission to obtain an apprentice license.

Mr. Williams was convicted for Felony Possession of Cocaine on September 9, 2012. He was placed on nine months intensive probation and thirteen months supervised probation.

Mr. Williams made remarks to the Board. The Board questioned Mr. Williams.

## 7. Lunch

***A motion was made, seconded and approved unanimously to adjourn for lunch at 1:00 p.m.***

***At 1:30 p.m., a motion was made, seconded, and approved unanimously to reconvene the meeting.***

8. Rules Committee Report

Board Counsel, Bain Jones, reported that the Board had met its requirement for soliciting for public comments regarding the recent posting on the Board's website as required by the Rules Commission. Mr. Jones advised that the Board received no inquires. Mr. Jones further advised that the Rules Committee will meet in July to prepare Rules revision recommendations at the Board's August meeting.

9. Board Member Names On licenses

Executive Director, Wayne Mixon, presented to the Board that the cost for changing Board member's names on licenses cost \$800 each time a change is needed. Mr. Mixon suggested not placing all of the Board member's names on the license and to only place the Chairman's name and the Executive Director's name or only the Chairman's name.

A motion was made by Mr. Crumley and seconded by Ms. Shannon to removed all Board member's names from the license and to only print the Executive Director's name as this is the name that is not likely to frequently change and thus potentially saving the Board thousands of dollars each year. The motion passed unanimously.

**Old Business**

10. Legal activities status report

Board Counsel, W. Bain Jones, Jr., presented the Board with updates related to various cases and probable cause to levy civil penalties against violators of G.S. 86A and the Board Rules. Mr. Jones made comments to the Board and the Board questioned Mr. Jones.

11. Legislative activity status report.

Board Counsel, W. Bain Jones, Jr., presented the Board with updates related to the activities taken by the General Legislature on issues that could affect the Board and/or the barbering profession directly or indirectly. Mr. Jones made comments to the Board and the Board questioned Mr. Jones.

12. New Computer System Report

Mr. Mixon reported that the field staff inspection piece is still in the development phase and should be online in the near future.

### **Executive Director Report**

#### 13. Finance Report

Executive Director, Wayne Mixon, reported on the financial condition of the Board. Mr. Mixon reported that the Board's finances are down considerably due to an irregular license renewal trend. Mr. Mixon further advised that he is hopeful that licensees are planning to submit late renewals. If not, this will have an adverse impact on Board operations.

### **Executive Session**

14. A motion was made by Chairman Warwick and seconded by Ms. Shannon to go into closed session pursuant to N.C.G.S. § 143-318.11(a)(3) and (a)(6). The motion passed unanimously.

A motion was made, seconded and unanimously passed to come out of closed session.

The Board rendered the decision to suspend the license of each respondent in the show cause administrative hearings for respondents' failure to pay past due civil penalties and attorney costs as ordered and for the respondents' license to remain suspended until such time as all civil penalties and attorney costs, including \$165.00 for the show cause hearing, are paid in full. The Board rendered the following decision regarding the appeal brought by Nenad Simic:

Approve Mr. Simic's request to open a barber school in a mall with separate non-adjointing spaces and with different mailing addresses providing the school is at one physical address.

The Board rendered the following decision regarding the appeal brought by Emmitt Blount:

- a) Petitioner shall pay the four hundred and fifteen dollars (\$415.00) for allowing an individual to practice barbering without a license.
- b) Petitioner shall pay an additional one hundred and sixty-five dollars (\$165.00) for the attorney's fees and costs for the hearing on June 16, 2014.
- c) For his gross malpractice and gross negligence, Petitioner's registered barber's license is revoked.

The Board rendered the decision to allow the petitioners to move forward with licensure as requested and to offer consent orders with the following requirements.

- a) Reginald Alston: Five year probation and completion of program to improve judgment and to learn good decision making skills.
- b) George Brown: Five year probation, completion of 30 day drug rehabilitation program and immediate drug screen.
- c) Michael Carmon: Five year probation and completion of program to improve judgment and to learn good decision making skills.
- d) Gino Coelho: Five year probation, completion of 30 day drug rehabilitation program and immediate drug screen.
- e) Roy Dail: Five year probation and completion of program to improve judgment and to learn good decision making skills.
- f) Jamel Davis: Five year probation and completion of program to improve judgment and to learn good decision making skills.
- g) Joe Ginyard: Five year probation, completion of 30 day drug / alcohol rehabilitation program and immediate drug screen.
- h) Jeffrey Gustus: Did not appear. No action taken.
- i) Marcus Harris: Five year probation and immediate drug screen.
- j) Kacey Hicks: Five year probation and immediate drug screen.



k) Ashley Jones: Five year probation and immediate drug screen.

l) Michael Link: Five year probation and immediate drug screen.

### **Adjournment**

15. A motion was made by Mr. Jackson and seconded by Mr. Crumley to adjourn the Board meeting until the next scheduled regular meeting on August 18, 2014. The motion passed unanimously.
